



# Project Board Member Recruitment






The Youth Housing Choices project is being developed and delivered by United Welsh and Llamau with Welsh Government Innovation Funding.

#### About Us

Caerphilly-based housing association United Welsh provides over 6,000 homes and related services across 11 local authority areas and is the largest provider of supported accommodation in Wales.

With a commitment to building homes, creating communities and transforming lives, United Welsh's supported housing includes accommodation for people with learning disabilities; physical disabilities; people with mental health challenges; substance misuse; people fleeing domestic abuse; individuals with complex needs and young people.

Llamau is the leading homelessness charity in Wales for young people and has extensive experience of providing accommodation-based services as well as a range of other homelessness prevention interventions that are highly regarded across Wales.

We recognise the wide variety of challenges that young people experience and we provide unprejudiced support that respects the backgrounds, circumstances and future aspirations of those we work with.

This is a natural partnership working together to provide a creative and innovative model of housing and support, forming a long-term housing and support solution to sit alongside already established supported accommodation services.

The core element of the new Youth Housing Choices project is that it is co-produced with young people and will:

- Be located in places that young people want to live
- Be priced at sub-market rents
- Support young people as part of the wider community
- Use an easy and straightforward application process
- Provide a responsible, safe and flexible landlord for young people
- Provide a psychologically-informed environment with support and guidance based on Housing First for Youth principles of support and engagement
- Not reinvent an existing model of supported accommodation

## The Role of the Project Board

The Project Board has responsibility for the leadership and governance of the Youth Housing Choices Project on behalf of United Welsh and Llamau.

While the parent Boards will maintain ultimate oversight, the Project Board has delegated responsibility to make decisions on the project in key areas.

The Project Board operates under the leadership of a Chair and works in partnership with key individuals in the Senior Management Team (Project Sponsors) in both parent organisations, as well as the Project Manager to set the strategic direction of the service; review performance; ensure risk is managed effectively and any statutory and legal obligations are fulfilled.

The Project Board is vital to ensuring that both the commercial and operational interests of the parent organisations are protected, and that most importantly, the project operates within the following values:

- Young people are at the centre of decision making
- · Young people's voices are heard
- The model can be flexible enough to meet the needs of a variety of young people
- The decision making is transparent and the views of each and every Project Board member are heard
- Project Board meetings are conducted in an inclusive manner, at times that are accessible for all, and in an environment that ensures that everyone can contribute and thrive.

#### The overall purpose of the Project Board is to:

- · Work collaboratively with the Project Management team in overseeing strategic planning and vision setting for the Youth Housing Choices project
- · Lead on the strategic decision making and direction of travel for the Youth Housing Choices Project
- Oversee the management of risk across a range of key areas, safeguarding the project and the partnership organisations
- · Undertake scrutiny of key decisions in relation to the project, both strategic and operational
- Have financial oversight and management, including budget setting and review
- Ensure the integrity of the operational delivery model and associated performance
- · Set a positive transparent culture of customer engagement and involvement at all levels of the project
- · Maintain a consistency of approach to strong governance arrangements, including reporting up to the parent Boards, and Welsh Government
- Support cross-boundary integration of the Youth Housing Choices Project
- Act as ambassadors for the Youth Housing Choices Project, building relationships and communicating with stakeholders external to the project.

## Each member of the Project Board, has a responsibility to:

- Attend and contribute to meetings unless reasonably otherwise constrained
- Contribute to work-streams relevant to their field
- Share information and best practice
- Support and advise the Youth Housing Choices Project Sponsors and Project Manager in enabling the delivery of agreed objectives
- · Respect and observe the normal codes of behaviour for meetings
- Respond to correspondence on issues relative to the partnership.
